

Telangana Govt Launches Cancer Day Care Centres Across All Districts

Hyderabad : In a revolutionary step for public healthcare, the Telangana Government has announced the establishment of Cancer Day Care Centres in every district of the state. Health Minister Damodar Rajanarasimha virtually inaugurated the centres at 34 Government General Hospitals (GGHs) from the Sangareddy Medical College on Tuesday.

The government has also decided to deploy 34 mobile cancer screening vehicles across the state to strengthen early detection and awareness at



the village level.

Speaking at the inauguration, Minister Rajanarasimha said cancer is one of the most dangerous non-communicable diseases and

often proves fatal if not diagnosed on time. He noted that lack of awareness and delayed diagnosis have been major hurdles in cancer treatment in Telangana,

which the government now aims to address through widespread screening facilities. Currently, specialty cancer departments with 80 beds are functional at NIMS and MGM hospitals. In the coming months, modern radiation bunkers with Day Care Centres will also be set up in Warangal, Sangareddy, Khammam, and Mahabubnagar districts. This initiative will enable patients to receive treatment in the morning and return home the same evening, significantly reducing both medical and financial burdens on families.

Wanaparthi millers face shifting row with civic officials

However, a miller in Pebber municipality allegedly continues large-scale shifting unchecked, using thousands of lorries daily, sparking concerns among other millers. Civic authorities have not issued shifting orders in Pebber, raising questions about unauthorized paddy movement, including shipments to neighboring Andhra Pradesh.
